Leaving a gift in your Will is one of the many ways you can provide financial support to those in the greatest need who are unable to pay for the life-changing technology and specialist ongoing care themselves. Each cochlear implant, including equipment and after-care, costs \$80,000 and our ever-growing waiting list exceeds more than 150 people every year.

It's never too early to start thinking about what you could leave behind – now could be the perfect time to share the gift of hearing and create a lasting legacy that will make a real difference to Aotearoa New Zealand, both now and for generations to come.

How your gift can help

Every gift, no matter what the size or amount, is deeply appreciated. You can choose to make a legacy gift of your remaining assets to support our work. Alternatively, you can make a specific bequest, which could include a set amount of money or a percentage of your estate.

Many of our donors choose to leave a monetary gift; however property, insurances, investments and other assets can also be gifted.

- Discuss your wishes with your immediate family and those close to you.
- Seek independent legal advice when writing or altering your Will, codicil or Family Trust/Inheritance Trust beneficiaries list.
- Notify us of your intentions so that we may express our gratitude during your lifetime and keep you up to date with our current work and future plans.

By leaving a gift in your will, you can ensure that SCIP will always be there for those in need. SCIP is many things to many people – a support system, a new beginning, a chance to re-enter society. Information for your solicitor or financial advisor

If you already have a Will, the wording below will help your legal advisor prepare a codicil to reflect any changes you wish to make. The same wording can be incorporated into your bequest clause if you are writing a Will for the first time. *(Delete as appropriate):* "I give Southern Cochlear Implant Programme the sum of \$...... (or a percentage, or the residue of my Estate, or a description of the property or asset given) for the general purposes of the Charity (or a stipulated purpose) and declare that the receipt of the Southern Cochlear Implant Programme to be a full discharge to my trustee".
